Dear Graham,

Many thanks for you lovely manuscript, "Salaam to the Infinite Energizer"! It stuck a fine chord with me. It is accepted. I have suggested some very minor revisions and made a few corrections (see enclosed copy). You will be hearing from Christy Frazier, Managing Editor, shortly, who will deal with you on whatever issues of changes, electronic format, etc. are required. Please deal with her on these matters, not me!

Now that our charitable New Energy Foundation is underway, I must bend every effort to seek financial supporters. We simply MUST close that \$150k to \$200k/year gap, or *Infinite Energy* cannot continue indefinitely. We have one major benefactor—Mr. Charles Entenmann (no longer in the baking business, and, no, he is not Jewish – assuming you or Mr. Dreyfoos are interested)— who keeps us alive (age 71+). I don't want the future of Infinite Energy to depend on his cardiac condition or whims. Therefore, I am enclosing hard copy of material, some of which is posted already to our web site, but other stuff still is waiting to be uploaded. I think you will find it to be more comprehensive a view of the situation than I have given before. AND – it has the advantage of trying to "shame" readers into donating. As long a shot as it is with Alex, why don't you copy this stuff for Alex Dreyfoos (and/or others) and send it along, with your message of cheer and encouragement. Hey, if he can give \$millions to MIT for a damned biology building, or whatever it was, maybe he can give \$150K or so to us – anonymously, if need be. He'd be a real *mensch*, if he did! Thank you.

Another matter. There is now that outstanding DVD of the Correa work – actual motors are seen working. Please try to shame him into ordering one (at \$43.95 total) from www.aethera.org This is PATENTED technology that is ripe for the plucking. He could be in the Gates league financially, if he did the right thing

with this. At least the guy should fund a small effort – at MIT, hah!? – to check out this plasma tube technology and all the other wondrous experiments that are now publicly described, buildable, and testable (everything BUT the not-yet-patented Aether motors). You will see yours truly on the DVD, introducing Dr. Aspden and the Correas –and subsequently being tickled, literally, by massfree ambipolar radiation coursing though my body,.

So as not to repeat myself, the following is the kind of message I send to people like Arthur C. Clarke, who got a spare DVD from us – a rare act, since we are too poor to afford to throw these around for free:

It has been some time since we've had direct communication. I do hope that this letter finds you well in this New Year! Just briefly to update you on a few matters;

- Enclosed please find the DVD, "From Plasma Power to the Aether Motor" which deals with the extraordinary accomplishments of Dr. Paulo and Alexandra Correa of Canada, whom I have told you about on previous occasions. You will see actual free energy devices working, which I and other can vouch for first hand. I introduce the DVD, and Dr. Harold Aspden of the UK (from 1963 to 1983 IBM's head of patent operations in Europe) gives further introduction, pointing out precisely where electromagnetic theory went wrong - namely, beginning about 1823! My great regret is that now realizing so clearly the tangible reality of the Correas' PAGD device, which appeared on the cover of IE #7 in 1996, I wasted so much time on many dead-end roads. Had we replicated PAGD in our lab years ago, as we most certainly could have done, we might have helped end the controversy years ago. Too much time was wasted on many dead ends in the cold fusion field, which is still mightily struggling to gain credibility-even though the basic published evidence cannot be doubted by sane, good-faith scientists. As you know, ICCF10 will be right near MIT this year - August 24-29.
- Cold Fusion Technology, Inc. still exists and has intellectual property holdings (filed patents) in Advanced Thermodynamics (a "polite" term for technologies that extend, i.e. violate, the infamous Second Law of Thermodynamics). However, Infinite Energy and our New Energy Research Laboratory— device testing facility—have been transferred to the non-profit New Energy Foundation, Inc. (a New Hampshire Corporation), which was set up in November 2002. Soon we will be posting a host of new material about NEF. I enclose hard copies of this material so you will be able to see what we are about. Those who donate to New Energy Foundation, Inc. receive the benefit of tax-deductibility on their contributions. And, we are certainly in need, so if the spirit moved you or any others— to contribute to our charitable work in New Energy, such revenues would be very much appreciated. You have been so

generous and fair in the past. You may copy this material to anyone you wish. Thank you!

- You may have seen a rather scathing commentary against the Correas and me, by implication— in a recent *Analog*. This by a former employee of ours, one Jeffery Kooistra. His comments were vindictive and are based on 100% ignorance of the experiment he was commenting on—the Reich-Einstein experiment. It was borderline libel on Kooistra's part, quite frankly. In any event, Stan Schmidt has graciously accepted a rebuttal letter from me and from the Correas, which will appear, he says, in the June issue (2003).
- Since Jed Rothwell has channeled himself so narrowly that he can only deal objectively with "cold fusion"/LENR, we have naturally had a falling out. I came to detest his reckless, mostly uninformed and in some cases slanderous attacks on e-mail forums against many reputable people in our field, from Dr. Mills of BlackLight Power to the Dr. Paulo and Alexander Correa. Rothwell has been removed from our masthead. The New Energy Foundation is run by a New Hampshire-based Board of directors.

Here is the bottom line, Art, whether you can accept it or not. At least THREE categories of New Energy (free energy) exist and are poised like daggers to utterly collapse the foundation of what poses for "science" today. All that is required is for actual engines based on these energy sources to enter the public arena. This will happen, and it will not take all that much money to make it happen. All three foundational paradigms of physics - relativity, quantum mechanics, and thermodynamics - are wrong at their roots. Of course, such predictions as these flawed theories make and are verified by measurement, are of course valid. But that does not mean that those paradigms (theories) are foundationally correct. They are not. You can understand that concept, I'm sure. But the scientific establishment, which thinks it has a "theory of everything" close at hand, cannot conceive of this. What a gigantic joke of history that modern science, born at the time of an Inquisition against free scientific investigation, should have itself become a supreme Inquisitor of those who question the fundamentals! The day of reckoning is coming. I hope you will be around to enjoy the delicious spectacle.
